We did it! The Evanston City Council voted 7-2 on Monday, December 12, to approve the Energy and Water Benchmarking Ordinance. Thanks to all of you who contacted your aldermen to show your support. Now the real work begins: helping the 500+ buildings covered by the ordinance to get set up and running. CGE will be organizing and training volunteers to assist building owners with the process. Evanston Takes the First Step Toward Local Regulation of Pesticides



The Evanston Environment Board has endorsed a Natural Habitat Evanston effort that would let Evanston have a voice in regulating pesticides. Currently, only the state can regulate pesticides and it has not proposed any such legislation. In response, Oak Park residents initiated this local effort at legislation, and other north shore communities are considering joining in. This is just the first step toward asking Illinois legislators to repeal state control of pesticide regulation.

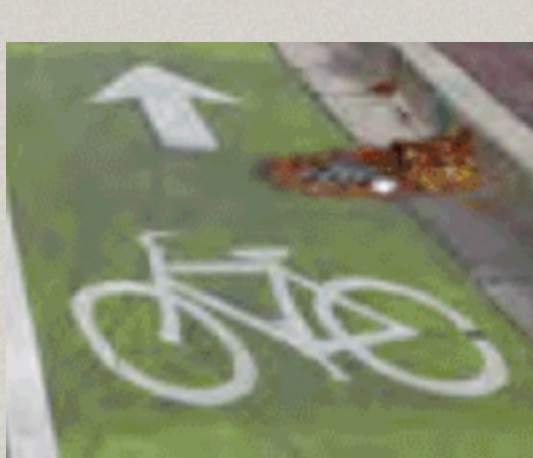
Environmental Justice: Our Next Green Drinks Topic on January 25

Evanston - A Bike-Friendly Community



Congratulations to Evanston for recently being designated a "Bicycle Friendly Community" by the League of American Bicyclists. The award recognizes a community's commitment to improving conditions for bicycling. In Evanston's case, the year's bike-friendly initiatives have included:

- Divvy Bike Share. In July, Evanston joined the region's Divvy Bike Share program, launching 10 stations and 100 bikes.
- Pedal Bright. Volunteers and staff installed more than 1,200 individual bike lights at two locations as part of the City's annual bike safety event on October 13.
- Dodge Avenue protected bike lane ride. The City and local bicycling community organized a guided tour of Evanston's newest bike infrastructure while also providing tips for safe riding.
- Bicycle Signage Pilot Program. The City partnered with Design for America's (DFA) Northwestern University Chapter to launch a Bicycle Signage Pilot Program at four locations.

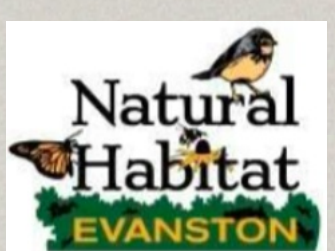
