

## Will You Be Affected by Evanston's Energy Benchmarking Ordinance?



Commercial and residential buildings are the largest single contributor to greenhouse gas emissions (GHG) in our community. If Evanston is to reach its climate goal of 80% reduction of GHG by 2050, it makes sense to target buildings as the largest area for potential reductions. That's why the City is developing energy and water benchmarking ordinances, which require property owners of affected buildings to aggregate and report their buildings' energy and water usage.

Who Does it Affect?

• City-owned buildings (10,000+ square feet) Privately owned buildings (20,000+ square feet)

How Must Buildings Comply? Buildings will be required to use Portfolio Manager, a free online tool administered by the U.S. EPA's ENERGY STAR program.

When Are Buildings Required to Comply? The largest buildings would be required to comply by June 30th, 2017.
