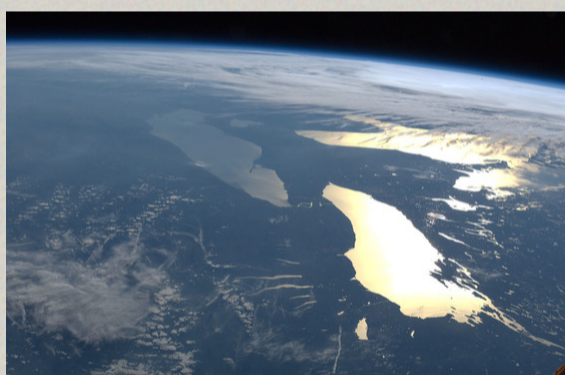

## Evanston Adds Three New Divvy Bike Stations

Three new Divvy Bike stations now increase access for Evanston riders on the west and northwest side of the city. Bringing the total number of stations to 14, these three new stations are located at:

- Levy Senior Center, Dodge Avenue at Mulford Street
- Lorraine H. Morton Civic Center, Ridge Avenue at Leonard Place
- Central Street at Lincolnwood Drive

Mayor Hagerty says he expects that new sponsorship agreements in 2019 will allow the Divvy program to operate at no cost to taxpayers.
