"Incorporate environmental justice into City ordinances, codes, policies and processes in consultation with stakeholders. "Create a meaningful public engagement policy and decision making process in collaboration with the City's Equity and Empowerment Commission. Develop and maintain a geographic information system (GIS) inventory of environmental justice areas in Evanston, defined as regions where there are likely to be disparities in access to environmental assets or exposure to hazards."
