1. What are the top 3 things you have you done in your personal life to reduce your own, or your family's environmental impact? \*

I led the movement to shut down the Northwestern University Hospital Medical Waste Incinerator. I also led the effort to restrict medical waste incineration at the state level which led to legislation restricting medical waste at the national level. We recycle, reuse, and I work very close to home and when possible I ride a bike or walk to work and other destinations.

2. List 1-4 steps you would take to help implement the CARP plan incorporating key City departments and decision-making processes. \*

I am currently researching cities of comparable scale that have made significant progress on the climate action front to compare municipal budget allocations towards this, to see, for example, what sort of staffing is necessary to effectively oversee CARP goals. I have discussed this as well as the need to also research cities that have effectively addressed impact of advancing climate goals while not harming low income communities with other candidates. I'm researching low income/ environmental justice component of implementation) now, along with staffing needs for the successful implementation of an environmental program so that we can hit the ground running once (hopefully) elected. I have been meeting with members of CGE and the Environmental Board to better understand the work and structure of the various groups working on CARP and to understand the measures (or lack thereof ) taken to date with regard to implementation. I will collaborate with Council and staff to immediately assess a backwards by design approach to achieving CARP goals and adapt our city budget in the short and long term to reflect the necessary steps and allocations to achieving the goals.

3. What are your top environmental or climate priorities for the City? \*

Fulfilling the CARP objectives, ensuring environmental justice is advanced, protecting and enhancing our lake front.

These surveys should be developed, and distributed, analyzed by same members of this community in collaboration with city staff, the Environmental Board and partnering organizations (CGE) to determine needs and course of action.
