1. What are the top 3 things you have you done in your personal life to reduce your own, or your family's environmental impact? *

(1) My husband and I built (and live in) a super sustainable house with a PV system that makes roughly 80% of our electricity; solar hot water collectors; triple-glazed windows; renewable and recycled materials; and a NWF-certified natural garden. (2) Our car is all-electric. (3) We offset our air travel with an annual contribution to the Climate Action Fund at the Evanston Community Foundation.

2. List 1-4 steps you would take to help implement the CARP plan incorporating key City departments and decision-making processes. *

(1) Provide more resources to our Sustainability Office. (2) Annually review and update the CARP Implementation Strategy. (3) Schedule regular updates (at least twice a year) to City Council on actions taken/underway to advance the Implementation Strategy.

3. What are your top environmental or climate priorities for the City? *

(1) Focus on interim CARP goals for 2025 and 2030: (a) increase waste diversion rate to 50% by 2025; (b) reduce building energy use by 25% (from 2005 levels) by 2025; (c) achieve 100% renewable electricity community-wide by 2030. (2) Strengthen restrictions and improve enforcement on the use of leaf blowers.
 (3) Continue to protect Isabella Woods from a threatened roadway easement to landlocked property in Wilmette.

4. The City just passed an Environmental Justice Resolution. What steps should be taken to ensure that Environmental Justice (EJ) is incorporated into City Code and that all City staff is trained to identify and tackle EJ issues? *

(3) Identify existing environmental and health risks in the community and develop and implement remediation programs. 5.
